Easiest & Best Ways to Give

- 1. Give Easily—Start or Increase Recurring Giving Online**
 - Use your phone and take a photo of the QR code below
 - Click on the link that appears and go to our giving site
 - If you prefer to use your computer, go to standrewlu.org/giving
 - Enter the amount you wish to give and the frequency
 - Pay by checking account or by credit card
 - It's safe, secure and efficient
 - Budget your giving to the church like your monthly cell phone, internet, and utility expenses to prioritize and contribute steadily to the church
- 2. Bill Pay**

Have your bank make automatic monthly payments directly from your checking account to St Andrew Lutheran Church.
- 3. Giving Envelopes**

Use church personal giving envelopes during Sunday worship service or send by mail to the church. (Please Note: If you no longer wish to receive giving envelopes, please let us know so we can save the expense of printing and postage)
- 4. Donate marketable stocks, mutual funds and bonds to St Andrew Lutheran Church**

We will provide simple instructions for the transfer.
- 5. Direct Charitable Distributions from your IRA or Donor Advised Fund**
 - This option offers significant tax advantages
 - A great way to give to the church
- 6. Bequests—Name St Andrew Lutheran Church as a beneficiary of your Life Insurance Policy, IRA, 401K, Trust, or Will**
 - Consider giving a portion of your estate to the church

 - In addition, leave a personal legacy of Christian Faith, Hope and Love to the church to continue to minister to the next generation
